2. ~~For the avoidance of doubt, applicable rates for crude oil transportation services will be charged on the net Crude Petroleum Barrel delivery quantities pursuant to Section 2, Rule 60 of the General Rules and Regulations published in Carrier's T.R.R.C. No. 1.4.0, including supplements thereto and successive issues thereof, but prior to any adjustment or assessment for inherent losses, including but not limited to shrinkage, evaporation, interface losses and normal "over and short" losses.~~

**PUMPING CHARGE**

- ~~Carrier will assess a fee of [C] **six and sixty four (6.64) cents per Barrel** for any pumping services performed in order to effect deliveries into the Alon Big Spring Refinery.~~
- ~~Carrier will assess a fee of [C] **seven and ninety eight (7.98) cents per Barrel** for any pumping services performed in order to effect deliveries into connecting carriers' pipelines at Carrier's CC Facilities.~~
