

AMENDMENT NO. 2
CONTRACT NO. 455-22-1027 FOR
SALESFORCE AND TOOLS IMPLEMENTATION SERVICES
BETWEEN
THE RAILROAD COMMISSION OF TEXAS AND
GUIDEHOUSE INC.

THIS AMENDMENT NO. 2 to Contract No. 455-22-1027("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas and Guidehouse Inc.(Vendor), located at 1676 International Drive, Suite 800 McLean, VA 22102 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 8.6. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, on July 9, 2024, the Parties executed **Amendment No. 1** to the Contract to modify section **2.1. CONTRACT AWARD.**, subparagraph (a.) to exercise renewal option one (1) of three (3) to continue the contract through the period of January 5, 2023-August 31, 2025 as approved by RRC Commissioners on June 25, 2024.

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

- I. **SECTION 2.1. CONTRACT AWARD.**, subparagraph (a.) is deleted in its entirety and replaced with the following:

"This contract is effective January 5, 2023, through August 31, 2026 (reflecting the original term of the contract plus the exercised optional renewal term two of three; collectively, "Contract Term") unless terminated earlier as provided in SOW 455-22-1027 Part 4 and/or section 2.2 TERMINATION set forth in the Contract.

This Contract may be extended only through written amendment to the Contract, fully executed prior to the expiration of the Contract Term in effect prior to execution of the applicable Amendment to the Contract.

RRC reserves the right to renew the Contract for one (1) additional, one-year renewal term remaining of the original three (3) one-year renewal terms.

- Third Optional Renewal Term: September 1, 2026 - August 31, 2027"

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be this Amendment No.2; then Amendment No. 1; and then the original Contract in accordance with section **1.3. ORDER OF PRECEDENCE.**, therein.

IN WITNESS WHEREOF, the Parties hereto have made and executed this Amendment No. 2 to the Contract to be effective as of the date of the last Party's signature hereto. By the signatures below, each signatory represents and warrants that they have the authority as of the date of their respective signature to enter into this Amendment on behalf of the respective Parties.
