**Notes:**

1. To the extent permitted by applicable law, all rates set forth above shall be increased annually, effective July 1 of each year (commencing July 1, 2016), by the positive adjustment, if any, in the FERC Index from the immediately preceding year; provided, however, any such annual adjustment shall (a) be limited to a maximum of three percent (3%) per year, and (b) not result in a rate less than the rate in effect immediately preceding such adjustment.
2. For the avoidance of doubt, applicable rates for crude oil transportation services will be charged on the net Crude Petroleum Barrel delivery quantities pursuant to Section 2, Rule 60 of the General Rules and Regulations published in Carrier's TX No. 63.0.0, as measured by Carrier pursuant to the General Rules and Regulations published in Carrier's TX No. 63.0.0, including supplements thereto and successive issues thereof, but prior to any adjustment or assessment for inherent losses, including but not limited to shrinkage, evaporation, interface losses and normal "over and short" losses.
3. The rate(s) to the Alon Big Spring Refinery are available pursuant to a Transportation Services Agreement with the Carrier.

**Pumping Charge**

- Carrier will assess a fee of [I] six and eighty-four hundredths cents (6.84¢) per Barrel for any pumping services performed in order to effect deliveries into the Alon Big Spring Refinery.
- Carrier will assess a fee of [I] eight and nineteen hundredths cents (8.19¢) per Barrel for any pumping services performed in order to effect deliveries into connecting carriers' pipelines at Carrier's CC Facilities.

**Truck Unload Charge**

- Shipments unloaded from tank truck facilities into Carrier's system are subject to a charge of [I] ten and ninety-two hundredths cents (10.92¢) per Barrel.
