## INSTRUCTIONS

**Generator** *(The generator of the oil & gas waste completes this section of the form)*

**Organization P-5 Number** – Enter the P-5 number for the generator’s organization.

**Organization Name** – Enter the name of the generator’s Organization as it is listed on the Form P-5 Organization report.

**Mailing Address** – Enter the complete mailing address of the generator's organization.

**Contact Name** – Enter the name of the person managing the permit/waste hauling process for the generator.

**Email Address** – Enter the email address for the person managing the permit/waste hauling process for the generator’s organization.

**Phone Number** – Enter the phone number for the person managing the permit/waste hauling process for the generator’s organization.

**Hauler Organization Name** – Enter the name of the authorized organization transporting the oil and gas waste.

**Waste Hauler Permit Number** – Enter the authorized waste hauler permit number.

**Designated Facility Name** – Enter the name of the organization where the oil & gas waste will be delivered.

**Facility Permit Number:** Enter the facility’s unique identification number assigned

**Facility Physical Address** – Enter the physical address of the designated facility where the oil & gas waste will be delivered.

**NORM** (Naturally Occurring Radioactive Material) – Indicate Yes or No if NORM is present in the waste.

**Waste Type** – Describe the waste type that is being transported (e.g., oilfield waste, construction debris, etc.).

**Container Type** – Enter the code below for the specific type of container that the oil & gas waste is being transported in.

Vacuum Truck = VT

Frac Tanks = FT

Drums Metal = DM

Tanker Truck- = TT

Flatbed Truck = FB

Tanks Portable = TP

Roll-Off boxes = RB

Dump Trucks = DT

Other = Fill box below with details

**Total Quantity** – Enter the total volume rounded to the nearest whole number.

**Units Weight/Volume** – Select the appropriate unit of measurement: Gallons (G), Barrels (BBL), Cubic Yards (CY).

**Commercial/Non-Commercial** – Indicate the type of facility using the dropdown.

**Out-of-State** – Indicate if the oil & gas waste will cross state lines by selecting Yes or No.

**State** – If yes was marked, that oil & gas waste will cross state lines and enter the other state.

**Generator's Signature** – Sign the form.

**Date Signed** – Using the calendar provided on the form, select the date of signing.

### Hauler's Acknowledgment of Receipt of Materials

*(To be completed by the hauler transporting the oil & gas waste)*

**Certification** – Read the declaration and ensure all information entered is accurate.

**Hauler Signature** – The hauler signs here acknowledging the receipt of materials.

**Hauler's Printed Name** – Hauler prints their name.

**Date Signed** – Using the calendar provided on the form, select the date of signing.

**Discrepancy** – The hauler will select the type of discrepancy if one is found.

### Disposal's Acknowledgment of Receipt of Materials

*(To be completed by the disposal facility receiving the oil & gas waste)*

**Certification** – Read the declaration and ensure all information entered is accurate.

**Disposal Signature** – The person signing on behalf of the disposal signs here, acknowledging the receipt of materials.

**Disposal's Printed Name** – The person signing on behalf of the disposal prints their name.

**Date Signed** – Using the calendar provided on the form, select the date of signing.

**Discrepancy** – The hauler will select the type of discrepancy if one is found.
