Rule 3.65



- Final rule adopted by Commissioners on November 30, 2021
- Rule is effective December 20, 2021
- First filing deadline is January 15, 2022

§3.65(b) Critical Designation Criteria



- Two Types of Critical Facilities
 - (1) Critical Gas Supplier; and
 - (2) Critical Customer.
- These facilities designated critical in an *energy emergency*.
- “Energy emergency” means any event that results in or has the potential to result in firm load shed required by the reliability coordinator of a power region in Texas.

Critical Gas Suppliers



The following facilities are critical gas suppliers:

1. Gas wells producing gas in excess of 15 Mcf/day;
2. Oil leases producing casinghead gas in excess of 50 Mcf/day;
3. Gas processing plants;
4. Natural gas pipelines and pipeline facilities including associated compressor stations and control centers;
5. Local distribution company pipelines and pipeline facilities including associated compressor stations and control centers;
6. Underground natural gas storage facilities;
7. Natural gas liquids transportation and storage facilities; and
8. Saltwater disposal facilities including saltwater disposal pipelines.

Critical Customers



A critical customer is a critical gas supplier (any facility listed on the previous slide) for whom the delivery of electricity from an electric entity is essential to the ability of such gas supplier to operate.

Critical Facilities



- A critical facility – whether a critical gas supplier or critical customer – must file a Form CI-D and CI-D attachment with the Railroad Commission.
- Form CI-D must be filed by January 15, 2022, *unless* the facility is eligible for an exception.
- A **critical customer** must also file the Form CI-D and the Form CI-D attachment with its electric entity.

Critical Customers Only



- Only a critical customer must provide the Form CI-D and CI-D attachment to the critical customer's electric entity.
- The Form CI-D and attachment must be emailed to the electric entity.
- Contact information for each electric entity will be made available on the Public Utility Commission's website.

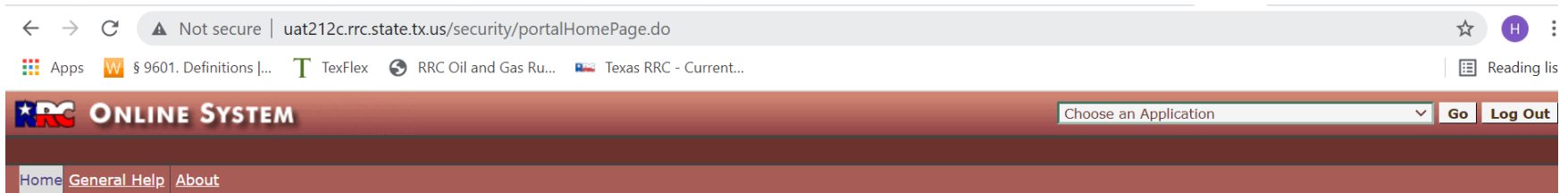

Form CI-D Certification for Critical Customers

IMPORTANT NOTICE: It is the sole responsibility of each critical customer as defined in §3.65(b)(2) to provide the Form CI-D and CI-D Attachment to its electric utility/utilities. Designation as a critical customer does not guarantee the uninterrupted delivery of electric service to your facilities.

CERTIFICATION: CRITICAL CUSTOMERS ONLY. By signing and submitting this Form CI-D, I certify that I, a critical customer as defined in §3.65(b)(2), have provided the Form CI-D and CI-D Attachment to the electric entities providing service to my acknowledged facilities as identified on the CI-D Attachment. I certify the information has been provided as required in 16 Tex. Admin. Code §25.52 and 16 Tex. Admin. Code §3.65.

- 16 TAC §25.52 requires Form CI-D and attachment to be provided by email. Email addresses for each electric entity will be available on the PUC's website.

Critical Designation Exception



- A facility designated critical must file Form CI-D *unless* the facility is eligible for an exception.
- The following facilities are NOT eligible for an exception:
 - a facility included on the electricity supply chain map;
 - gas wells or oil leases producing gas or casinghead gas in excess of 250 Mcf/day;
 - gas processing plants;
 - natural gas pipeline facilities that directly serve local distribution companies or electric generation;
 - local distribution company pipeline facilities;
 - underground natural gas storage facilities;
 - natural gas liquids storage and transportation facilities; and
 - a saltwater disposal facility that supports a facility listed above.

Critical Facilities Eligible for Exception



- The following facilities may apply for an exception by filing Form CI-X:
 - Gas wells producing >15 Mcf/day and <250 Mcf/day
 - Oil leases producing >50 Mcf/day and <250 Mcf/day in casinghead gas
 - Natural gas pipelines and pipeline facilities that do not directly serve local distribution companies or electric generation
 - Saltwater disposal wells and pipelines that do not support a facility listed under §3.65(e)(1)-(7)

- A Form CI-X Exception Application must include:
 - (1) \$150 per operator; and
 - (2) Objective evidence of a reasonable basis and justification in support of the application, such as:
 - all of the gas produced at the facility is for on-site consumption; or
 - the facility does not otherwise provide gas for third-party use.
- Form CI-X and its attachment may be filed through the RRC Online Filing System or via email to FormCIX@rrc.texas.gov



2022

- First filing due January 15, 2022
- Second filing due September 1, 2022, or 30 days after the electricity supply chain map is issued, whichever is later

2023 forward

Biannual filing of Form CI-D and CI-X required by March 1st and September 1st of each year.

Exceptions Not Transferable



- Exceptions are not transferable upon a change of operatorship.
- If the facility has an exception, the exception shall remain in effect until the next bi-annual filing deadline. If the transferee operator seeks to continue the exception beyond that time period, the transferee operator shall indicate the transferred facility on the Form CI-X.

Request For Critical Designation



- §3.65 (c)(1) - A facility not designated critical under §3.65(b) *may* request critical designation if the facility's operation is required in order for another facility designated critical to operate.
- §3.65 (c)(2) - A facility not designated critical under §3.65(b) *shall* request critical designation if the facility is included on the electricity supply chain map.
- A request shall be in writing submitted to the Commission and shall include evidence that the facility qualifies for critical designation under one of the two categories listed above.

Failure to File or Provide Information




- An operator who fails to comply with Section 3.65 may be subject to penalties under §3.107 of this title (relating to Penalty Guidelines for Oil and Gas Violations).
