Applicant Information

1) Complete the student's name and address contact information. The *Social Security Number* is required.

The *RRC License Number* is required and is found on the company wall license. If the individual is not employed by a company leave the *Company Name* and *RRC Company License Number* blank.

Employee-Level Examinations

2) Select the employee-level or management-level examinations needed.

Delivery Truck Driver – Covers activities related to operating a transport, loading and unloading LNG and connecting and disconnecting transfer hoses, and all activities related to stationary LNG systems, including LNG containers, piping and equipment.

Service and Installation Technician – Covers all activities related to stationary LNG systems, including LNG containers, piping and equipment. It does not cover filling containers or operating an LNG transport.

Transport Truck Driver – Covers the operation of an LNG transport including loading, unloading and connecting and disconnecting transfer hoses. It does not cover the installation or repair of transport systems.

Engine Fuel – Covers the installation of motor fuel containers and motor fuel systems, including replacement of container valves on motorized vehicles licensed to operate on public roadways. It does not authorize filling of containers.

Motor/Mobile Fuel Filler– Covers the inspection and filling of motor or mobile fuel containers on vehicles, cars, trucks and buses. It does not cover the filling of stationary LNG containers.

Management-Level Examinations

Descriptions of management level examinations can be found in Section 14.2019(c) of the Regulations for Liquefied Natural Gas.
