Note 1: The Committed Shipper Rates are applicable to any Shipper that has an effective transportation services agreement with Arrowhead Eagle Ford Pipeline, LLC, wherein the Shipper has agreed to ship, or otherwise pay for, a minimum volume of crude petroleum from one of the origin points to the destination point in this tariff, over a one-year period.

Note 2: The Uncommitted Shipper Rates apply to any Shipper that is not a Committed Shipper.

UNLOADING CHARGE: All shipments unloaded by tank truck into the mainline facilities under this Arrowhead/Gray Oak Joint Tariff No. 1.1 will be subject to a charge of ten and sixty-one hundredths cents (\$0.1061) per barrel in addition to the transportation rates named herein.
