A "Special Handling" fee of **[U]** 13.73 cents per barrel will be charged for crude petroleum moved from Magellan's Speed Junction connection into Magellan's Houston Fuel Oil Terminal Company connection at Speed Junction.

A "Special Handling" fee of **[U]** 13.73 cents per barrel will be charged for crude petroleum moved from Magellan's BridgeTex connection **[C]** ~~Converge connection~~ or KMCC Pipeline connection at Genoa Junction into Magellan's ExxonMobil Pipeline's connection at Genoa Junction.

A "Special Handling" fee of **[U]** 13.73 cents per barrel will be charged for crude petroleum moved from Magellan's BridgeTex connection, **[C]** ~~Converge connection~~, KMCC Pipeline connection, or Enterprise connection at Genoa Junction into Magellan's Seabrook Pipeline connection at Genoa Junction.

[C] A "Special Handling" fee of ~~13.73 cents per barrel will be charged for crude petroleum moved from Magellan's BridgeTex connection at Genoa Junction into Magellan's Converge connection at Genoa Junction.~~
