

**AMENDMENT NO. 1
CONTRACT NO. 455-23-1008
BETWEEN**

**THE RAILROAD COMMISSION OF TEXAS AND
HEALTH AND HUMAN SERVICES COMMISSION**

THIS AMENDMENT NO. 1 to Contract No. 455-23-1008 (“Contract”) is entered into by and between the State of Texas, acting through the Railroad Commission of Texas (“RRC”), located at 1701 N. Congress Ave., Austin, Texas and Health and Human Services Commission for Communication (“Performing Agency”), located at 4900 N. Lamar Blvd., Austin, TX 78751 (individually, “Party”; collectively, “Parties”).

WHEREAS, SECTION VI. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

I. SECTION 6.01. TERM, is deleted in its entirety and replaced with the following:

“This Contract shall be effective January 1, 2023, through December 31, 2025 (reflecting the original term of the Contract plus the exercised optional renewal term one of three: collectively, “Contract Term” unless terminated earlier as provided in IAC No. 455-23-1008 set forth below.

The contract may be renewed for two (2) additional one-year renewal terms prior to the expiration of the current term.

Second Renewal Term: January 1, 2026 – December 31, 2026

Third Renewal Term: January 1, 2027 – December 31, 2027

Except as expressly amended above, all provisions of the Contract remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 1; and then the original Contract, therein.

IN WITNESS WHEREOF, the Parties hereto have made and executed this Amendment No. 1 to the Contract to be effective as of the date of the last Party’s signature hereto. By signatures below, each signatory represents and warrants that they have the authority to amend the Contract on behalf of the respective Party.
