For every 50 miles of 20-inch pipeline there are 1,650 fewer trucks on our roads.

Texas has the largest pipeline infrastructure in the nation, with 489,657 miles of pipeline representing about 1/6 of the total pipeline mileage of the entire United States.

Texas was the first state in the nation to adopt pipeline safety regulations. The Railroad Commission of Texas regulates pipeline safety during construction and operation of the pipeline. The agency does not have jurisdiction over eminent domain or routing.
