## Oil and Gas Division Permitting Efficiencies Report

The Railroad Commission’s (RRC) Oil and Gas Division receives, reviews, and approves a variety of 35 different types of permits for Oil and Gas related activities. The review and approval processes of the permits are managed by fifteen (15) units and ten (10) district offices within the Oil and Gas Division. Permits that have been administratively denied are eligible for reconsideration by the RRC’s Hearings Division at the request of the applicant, and all contested applications are subject to a hearing.

To meet the rule requirements of 16 Texas Administrative Code § 1.201 for reviewing and approving RRC Oil and Gas Division issued permits, the RRC maintains the full-time employee positions listed below in the division’s permitting units and district offices. Additionally, the RRC’s Hearings Division maintains the full-time employee positions listed below to respond to applicants who request a hearing for oil and gas matters.
